



# **Badminton**

## **Regulations Badminton**

#### **Team tournament**

- 1. Each member city/student sports board is allowed to register one team. A team consists of a minimum of four persons, namely two men and two women and a maximum of eight persons, namely four men and four women. When there is space for more entries, the organisation may decide to open the registration for a second team per member city/student sports board.
- 2. Each team of a member city/student sports board may only consist of students who meet the conditions as stated in chapter 1 of SSN's event regulations. If this rule is violated, the respective team shall lose all games in which this rule is violated 8-0.
- 3. If an ineligible participant competes in the GNSK, a €200 fine will be charged to the member city/student sport for which that participant competes. Also, the results of that team will be deleted.
- 4. Team entries must be made at the competition secretariat before the start of the tournament.
- 5. The team line-up must be exchanged simultaneously with the opponent before the match.
- 6. The team matches consist of: two women's singles, two men's singles, one women's double, one men's double and two mixed doubles. Should there be insufficient playing time, the tournament management reserves the right to change the number of matches to five matches, consisting of: one women's single, one men's single, one women's double, one men's double and one mixed double. If this is decided, the results of the remaining three matches will be forfeited for the standings. This applies retroactively.
- 7. Eight matches per team match will be played in the following order: a men's double, a women's double, a first men's single, a first women's single, a second men's single, a second women's single, a first mixed double and a second mixed double. By agreement between the teams, the order may be changed.
- 8. During the eight matches of a team match, a player may be deployed a maximum of three times. If a team match contains five matches (only one match of each section) a player may be deployed a maximum of two times. In either case, a player may deploy only once in each event
- 9. A match consists of two winning sets, i.e. 'best-of-three' principle. A set is won when a score of 21 points is reached with at least two points difference. If there is no difference of two points, the set continues until there is a difference of two points or the maximum score of 30 points is reached.
- 10. Each team must provide a counter (person) for their own matches to conduct matches. Except for the finals, where the organization will provide a counter.
- 11. The pools will be drawn by lot.
- 12. After a match, teams will receive points based on the number of matches won. If teams finish with an equal number of wins, the total number of sets won minus the number of sets lost will be taken into account. If teams still finish tied, then the total number of points won minus the number of points lost will be considered.
- 13. The scoring is based on the current regulations of Badminton Nederland.
- 14. For each team match (so 8 individual matches) the organization will provide feather shuttles. These shuttles must be returned to the sports committee by the team captains after the match.









- 15. Teams must be ready to play at the time indicated in the tournament schedule. If this is not the case, the match will be declared lost. The result will then be 8-0 in favor of the team present. If 5 games were to be played, the result is a 5-0 win for the team present.
- 16. Players must wear appropriate sportswear. Shoes with black soles are not allowed.
- 17. As far as these competition regulations do not provide, the regulations of Badminton Nederland are in force.
- 18. In all cases, the Sports Committee reserves the right to make a binding decision not similar to the above.

#### **Individual Tournament**

- 1. Per member city/student sports board multiple athletes can be registered. Based on the number of registrations it can then be determined whether there will be played according to a pool schedule or via an elimination system.
- 2. Players must be students who meet the conditions as stated in chapter 1 of SSN's event regulations. In case of violation of this rule, the player concerned will lose all matches in which this rule has been violated.
- 3. If an unauthorized participant competes in the GNSK, a €200 fine will be charged to the member city/student sports board for which that participant competes. Also, the results of that player will be deleted.
- 4. Player entries must be made to the match secretariat before the start of the tournament.
- 5. A match consists of two winning sets, thus 'best-of-three' principle. A set is won when the score reaches 21 points with at least two points difference. If there is no difference of two points, the set continues until there is a difference of two points or the maximum score of 30 points is reached.
- 6. In principle, no counters will be arranged for these games. It is expected that players keep score during the match or arrange their own counter. Only for the finals will the organization provide a counter.
- 7. Classification will be made by drawing lots.
- 8. If a pool format is used, players will receive one point for each match won. If players end up with an equal number of matches won, the total number of sets won minus the number of sets lost will be considered. If players then still finish tied then the total number of points won minus the number of points lost will be considered.
- 9. The scoring is based on the current regulations of Badminton Nederland.
- 10. The organization will provide feather shuttles for each match. These shuttles must be returned to the sports committee after the match.
- 11. The players must be ready to play at the time indicated in the tournament schedule. If not, the match will be declared lost in favor of the player present.
- 12. Players must wear appropriate sportswear. Shoes with black soles are not allowed.
- 13. As far as these competition regulations do not provide, the regulations of Badminton Nederland are in force.
- 14. In all cases, the Sports Committee reserves the right to make a binding decision not similar to the above.









### File a protest:

#### Protest must be submitted up till one hour after the end of the match.

Participants or teams can file a protest against other participants/ teams based on eligibility and competition rules. Decisions of referees or other officials cannot be challenged, nor can the regulations of the GNSK, the regulations of the camping and other articles from the event regulations of Studentensport Nederland.

To file a protest, the teams have to do the following:

- The sports committee must be notified of the protest as soon as possible after the end of the match, during which the alleged violation has occurred.
- The person to be called: to be determined
- The protest must be signed by an official representative of the team and must contain the following elements:
  - Date, time and location of the incident
  - The relevant article which was violated
  - A description of the situation
  - The names of the protesting team/participants, signed.

On Saturday, the protests will be processed at the end of the day. On Sunday, the protests will be processed no later than two hours after the protest has been submitted. All protests must be dealt with before the start of the finals.
