# Regulations Squash

1. Per member city/student sports board a maximum of one mixed team can be registered. A team consists of a minimum of 3 and a maximum of 5 (2 substitutes) players which includes at least 1 female and 1 male. Multiple individuals per member city/student sports board can be registered for the general tournament, including participants of the team tournament.
2. The registered participants of each member city/student sports board are only allowed to consist of students that comply with the terms and conditions as stated in chapter 1 of the event regulations of SSN. Violation of these regulations causes the team or individual to lose all games.
3. If an ineligible participant takes part in the GNSK, a fine of €200,- will be charged to the member city/student sports board for which the participant plays. Additionally, the results of the team or individual concerned will be scraped.
4. At registration for the team tournament, the order of each participant's playing strength within the team must be indicated. Meaning: the strongest player on 1, the second strongest player on 2 etc.
5. The personal playing strength that applies to the squash federation, if available, should be indicated at registration(so: a, b, c, d or e).
6. The composition of each team must be submitted to the committee and is, thereafter, not allowed to be altered during the game. So, it is allowed to make use of substitutes, when this has been reported for the specific game.
7. A team plays 3 games of singles versus another team (1 ladies singles, 1 gents singles, and a game of singles between the two third players). Every won game is worth 1 point.
8. Games will be played according to the PAR-11 format. PAR is an abbreviation for Point-A-Rally. The first player to reach 11 points has won the game. If the score is 10-10, the game will continue until the difference is 2 points. At first, games will be played according to the best-of-three principle, however, the committee reserves the right to change this to a best-of-five principle.
9. When in a group two teams or individuals end on an equal score, the following order is decisive:
  - i. Results between the two (only if two teams end on an equal score)
  - ii. Amount of acquired games (wins minus losses)
  - iii. Amount of acquired points (wins minus losses)
  - iv. Amount of acquired games (wins)
  - v. Amount of acquired points (wins)
10. Besides playing the games, players need to act as a referee at games between to other teams or individuals. Non-playing teams or individuals should delegate a referee for this according to schedule.
11. The division of the groups in the qualifying rounds is decided by drawing of lots.

12. The teams and individuals need to be ready to play at the given time on the playing schedule. If the team or individual is not present at the given time, they lose the game. The final score will then be 2-0 or 3-0 (11-0, 11-0, 11-0) in favour of the team or individual present.

13. If a team does not have 3 legitimate players at the start of the game, all players within the team have to move, so that the highest positions within the team are occupied. The games for which no players are available will be declared lost for the team concerned. The final score of those games will then be (11-0, 11-0) or (11-0, 11-0, 11-0).

14. Participants have to wear shoes that do not leave stripes or dirt on the squash court.

15. As far as in the points above no exception has been made, the regulations of the Squash Bond Nederland (SBN) will be in force.

16. In all instances, the committee reserves the rights to take a binding decision.

## File a protest:

**Protest must be submitted up till one hour after the end of the match.**

Participants or teams can file a protest against other participants/ teams based on eligibility and competition rules. Decisions of referees or other officials cannot be challenged, nor can the regulations of the GNSK, the regulations of the camping and other articles from the event regulations of Studentensport Nederland.

To file a protest, the teams have to do the following:

- The sports committee must be notified of the protest as soon as possible after the end of the match, during which the alleged violation has occurred.
- The person to be called: *to be determined*
- The protest must be signed by an official representative of the team and must contain the following elements:
  - Date, time and location of the incident
  - The relevant article which was violated
  - A description of the situation
  - The names of the protesting team/participants, signed.

On Saturday, the protests will be processed at the end of the day. On Sunday, the protests will be processed no later than two hours after the protest has been submitted. All protests must be dealt with before the start of the finals.
