



## 1. Acces

- **1.1** Acces to GNSK locations and venues is only possible when you are in possession of the online accreditation and when all requirements regarding eligibility are met .
- **1.2** Following information is stated on the online accreditation: Name of the individual, photo of the individual, the sport in wicht he participant is active and the city which is represented by the indiviual
- **1.3** To be eligible to compete in any competition a proof of enrollment/diploma from your higher education institution should have been provided and the participation fee must have been paid.

## 2. Eligibility

- **2.1** The eligibility is valid from Friday 9th of June until Sunday 11th of June 2023.
- **2.2** The organisation of GNSK 2023 charges a participation fee. This fee has to be paid in advance. Individuals will only receive the online accreditation when the full payment is received

## 3. Registration/Participation Fee/Cancellation

- 3.1 The amount of the participation fee depends on whether you are an athlete or coach/official during the GNSK 2023. Participation fee for athletes have been established on €65,- per person whereas coaches/officials shall pay the amount €30,- per person.
- **3.2** In team sports, the responsibility for payment lies with the team captains and in individual sports the payment lies with the participating individual.
- **3.3** Cancellation with (full) refund of the participation fee is only possible until May 9th. After May 9th (full) refunds in case of cancellations are no longer possible. Please take not of the registration deadlines on our website.
- **3.4** To properly check whether a registered athlete is actually a student in the city they represent proof of enrollment/diploma should be provided when registering prior to the GNSK 2023 as well as during the registration the weekend itself.
- **3.5** The organisation of the GNSK 2023 uses personal data exclusively for administrative purposes.
- **3.6** Each team/individual is only considered a participant when all necessary documents and participation fee have been received.

#### 4. Accreditation

- **4.1** During the GNSK 2023 all individuals needs to be in possession of the online accreditation.
- **4.2** Upon arrival at the GNSK 2023 everyone must present their online accreditation at the registration desk

#### 5. Violation

**5.1** Right of participation is strictly personal. The organisation of the GNSK 2023 reserves the right to delete results and isseu fines in case of violation of the internal regulations.





## 6. Liability/insurance

- **6.1** Participation in the GNSK 2023 is at own risk. At all times, adhere to the sport-specific rules and dress code as laid down in the competition regulations.
- **6.2** The organisation of the GNSK 2023 is not liable for damage, loss or theft of any personal belongings.
- **6.3** Damage from destruction or improper use of properties will be recoverd from the respective offender(s) in question.

## 7. Sports programme

- 7.1 The sports programme of the GNSK 2023 will be presented online.
- **7.2** The organisation of the GNSK 2023 reserves the right to make changes in the sports programme at all times.
- **7.3** The organisation of the GNSK 2023 has the obligation to inform all participants of any changes by e-mail, GNSK App, social media, website and/or newsletters.

## 8. Cancellation of events

- 8.1 The organisation of the GNSK 2023 strives not to cancel any NSK represented at the GNSK.
- 8.2 If in any case there is reason to cancel an NSK, the participation fee will be refunded.
- **8.3** If in any case there is a cancellation of an NSK, the organisation of the GNSK 2023 has to obligation to inform all participants through various channels. At least all registered individuals in the relevant event will receive an informative e-mail.

#### 9. Complaints

**9.1** Suggestions and complaints can be sent to <u>info@studentensport.nl.</u> Suggestions and complaints can also be sent via the contact forms on the website or GNSK app. The organisation of the GNSK 2023 strives to reply via e-mail within 7 days.

#### **10.** Obligation of the organisation

- **10.1** The organisation of the GNSK 2023 is responsible for the required maintenance of the facilities during the event.
- **10.2** The organisation of the GNSK 2023 is responsible for providing event venues with sufficient people with the right skills, qualifications and diplomas.
- **10.3** The organisation of the GNSK 2023 ensures sufficient first aid resources at the various sport veneus.
- **10.4** The organisation of the GNSK 2023 is responsible for providing the correct documentation to all participants as proof they met the requirements.
- **10.5** The organisation of the GNSK 2023 is responsible for the implementation of the entire event weekend from 9 to 11 June, namely organisation of the NSK's, organisation of additional events, side programmes and parties as well as the provision of sleeping places and meals. (Saturday: breakfast, lunch and dinnner, Sunday: breakfast and lucnh).





# 11. Obligations of the participant

- 11.1 Oneigenlijk gebruik van materiaal of faciliteiten zonder voorafgaand overleg met de organisatie van het GNSK 2023 is nadrukkelijk verboden.
  Particpants are obliged to follow instructions of the organisation of the GNSK 2023 and comply with the internal regulations at all times.
- **11.2** Improper use of material or facilities without consultation with the organisation of the GNSK 2023 is strictly forbidden.
- **11.3** Participants may not use any sports facilities when they are under the influence of alcohol and/or drugs or when there are substances involved that are referred to as doping.
- **11.4** Smoking on the WUR Campus and outdoor sports facilities is prohibited.
- 11.5 Participants are obliged to communicate any changes to personal data to the organisation of the GNSK 2023 as soon as possible via e-mail. This can be done via info@studentensport.nl. If changes are not communicated in a timely manner and incorrect data ends up in the online accreditation acces to GNSK 2023 may be denied.

#### 12. Privacy policy

- **12.1** When registering fort he GNSK 2023 you give permission to the organisation of the GNSK 2023 to process a number of data. These are: name, date of birth, personal contact details; proof of enrollment/diploma; photo; data showing dietary preferences, allergies and other relevant and important information for the organisation of the GNSK 2023.
- **12.2** The organisation of the GNSK 2023 uses these data fort he benefit of participants administration; check of accreditation; communication and acces to the venues and events.
- **12.3** The data processed by the organisation of the GNSK 2023 are only intended for GNSK purposes and are not provided to third parties. The GNSK 2023 data files are not linked to third-party data files. However, the organization of the GNSK 2023 reserves the right to make the data available for participation in research. In that case, the data will be anonymized and cannot be traced back to individual persons.
- **12.4** The processed data is secured in such a way that it is not accessible to third parties. This also applies to the backups that are made of the files.
- **12.5** The data will be kept for one year after the GNSK 2023 after which it will be anonymised or deleted.
- **12.6** Participants can request the organisation of the GNSK 2023 to delete their data at any time. If this is done prior to the GNSK 2023 of 9-11 June 2023, the registration will therefore be cancelled
- **12.7** When registering for the GNSK 2023, you give permission to the organisation of the GNSK 2023 to use the photos taken on behalf of the organisation of the GNSK 2023. Each participant hereby has the right to request the removal of a photo and the organisation of the GNSK 2023 will then remove this photo.
