

Campsite regulations

These campsite regulations are intended to ensure that everyone has an enjoyable weekend. The organisers and security staff reserve the right to immediately remove anyone who fails to comply with these rules from the campsite or sports hall.

1. It is mandatory to listen to security staff, organisers and volunteers at the campsite.
2. The general terms and conditions of GNSK 2026 apply at the campsite.
3. Visitors only have access to the campsite upon presentation of their accreditation in the GNSK 2026 App after registering at the registration desk in the USC.
4. The organisation and its volunteers are in no way responsible and/or cannot be held liable in any way for any damage, in the broadest sense of the word, whether material and/or immaterial, to/by third parties or for theft. Valuable property must be removed from the premises.
5. Camping in the designated area.
6. Your own tent must be suitable for the number of people who will be sleeping in it. If the tent is too large for the number of people, the organisation may refuse the tent.
7. Caravans, motorhomes, tent trailers, party tents and army tents are not permitted.
8. Passenger cars are not permitted on the campsite; they can be parked at P7 for a fee.
9. The campsite is open from Friday 5 June at 4 p.m. Tents may remain on the campsite until 6 p.m. on Sunday 7 June at the latest.
10. Arrival at the campsite is possible until Saturday 6 June at 8 p.m. Upon your first arrival at the campsite, please report to the volunteers who will assign you a place to stay.
11. The campsite will be supervised by security and/or volunteers throughout the weekend. In case of emergencies, please refer to these staff members and/or the central information point at USC.
12. There are sufficient toilets next to the campsite. Please keep these facilities tidy and clean so that the next person can also use a clean toilet.
13. There is no electricity supply on the campsite.
14. Open fires, including barbecues and gas bottles, are prohibited. Cooking is not permitted for fire safety reasons.
15. Rubbish must be disposed of in the designated bins.

16. Please be considerate of your fellow campers' sleep. The campsite must be quiet between 11 p.m. and 7 a.m. The use of sound systems is therefore prohibited during these hours.
17. Pets are not permitted on the campsite.
18. Trade, advertising or publications near the entrances or on the campsite are only permitted with the prior written consent of the organisation.
19. You may bring your own food and drink (with the exception of alcohol) and consume it on the campsite, provided that everything is cleaned up upon departure.
20. It is not permitted to consume any form of alcohol or drugs on the campsite.
21. Glass is prohibited on the campsite for safety reasons. Bags will be checked upon arrival at the campsite.
22. Smoking is not permitted anywhere on the campus.
23. When leaving the campsite on Sunday, security and volunteers may check whether the camping spot has been left clean and tidy. You may be asked to clean up any rubbish left behind.
24. If you use the services of Camp Again, you must also comply with their rental conditions.
