As the organization of the GNSK, we consider your privacy important and therefore handle your personal data with care. Which personal data we process and how we do so is explained in this privacy statement.

Personal data

We only process the personal data that you provide to us yourself for your participation in the GNSK, with the exception of photos taken during the event. This concerns the following data.

Team registration via Google Forms

If you register a team for the GNSK, we record the following personal data in a Google Forms file:

- First and last name
- Email address
- Telephone number

Individual registration via aanmelder.nl

To register as a participant for the GNSK, you use the registration platform aanmelder.nl. By registering via aanmelder.nl, you give us permission to process the data you provide. This includes:

- First and last name
- Date of birth
- Email address
- Telephone number
- Proof of enrolment at your educational institution
- Allergies and/or dietary preferences

Accreditation card in the GNSK app

During the GNSK, you identify yourself and show that you are participating in a sport by means of an accreditation card. You generate this card in the GNSK app. To generate the accreditation card, we process:

- First and last name
- Email address
- Telephone number
- Passport photo

Photos and videos during the GNSK

Photos and video recordings are made during the GNSK. These images are published on the website and social media channels. If you do not wish to be visible in certain images, please send an email to info@studentensport.nl stating the relevant image material, and we will handle your request. The images will be removed or you will be made unrecognisable. We will process your request within 4 weeks.

Purpose and legal basis

We process your personal data on the legal basis of performance of an agreement and legitimate interest, and with the following purposes:

- Participant administration and the processing of your payment
- Verification of eligibility to participate (through the use of the accreditation card)
- Necessary contact (via email, telephone or push notifications in the app) regarding your participation in the GNSK
- Providing an impression of the atmosphere of the GNSK on the website and social media channels

Retention period

We retain your personal data until one year after the GNSK in which you participated. After that, your data will be deleted. If you would like your data to be deleted earlier, you can send an email to info@studentensport.nl and we will delete your data within 4 weeks.

Sharing with third parties

We do not sell your data to commercial third parties and will only provide it when this is necessary for the performance of our agreement with you or to comply with a legal obligation. The GNSK data files are not linked to data files of third parties.

We do reserve the right to make data available for research and educational purposes in higher education, for example for internships or graduation projects. In such cases, the data will be anonymised and cannot be traced back to individual persons.

With companies that process your data on our behalf, we conclude a data processing agreement. We remain responsible for these processing activities.

Cookies

No cookies are used on the GNSK platforms.

Access, modification or deletion

You have the right to access, modify or delete your personal data. To do so, please contact us via info@studentensport.nl. If you wish to have your data deleted before the start of the GNSK, your participation will lapse. It is possible that any costs already incurred for participation will not be refunded, please refer to the general terms and conditions of the relevant GNSK.

In addition, you have the right to withdraw any consent you have given for the processing of your data or to object to the processing of your personal data, and you have the right to data portability. This means that you can submit a request to us to send the personal data we hold about you in a computer file to you or to another organisation designated by you.

You can send a request for access, modification, deletion, data transfer of your personal data, or a request to withdraw your consent or object to the processing of your personal data to info@studentensport.nl. Please do this using the email address you used to register for the GNSK, so that we can verify your identity.

You also have the option to submit a complaint to the national supervisory authority, the Autoriteit Persoonsgegevens (Dutch data protection authority).

Data protection

We take the protection of your data seriously and take appropriate measures to prevent misuse, loss, unauthorised access, unwanted disclosure and unauthorised modification. This includes:

- Securing our website with an SSL certificate so that confidential information is transmitted in encrypted form.
- Keeping our software up to date and using a firewall
- Concluding data processing agreements with third parties that process your personal data on our behalf.
