

General Terms & Conditions

GNSK 2026

1. Access

- 1.1. Access to the GNSK venues is only permitted if all participation requirements have been met and the participant is in possession of the correct documentation (online accreditation card in the GNSK app).
- 1.2. The accreditation card includes a passport photo, the participant's name, the participant's city, and the sport in which the participant is competing.
- 1.3. To participate, a valid proof of enrolment at a Dutch educational institution must be submitted in advance and the registration fee must have been paid.

2. Validity

- 2.1. Participation rights are valid from Friday 5 June 2026 up to and including Sunday 7 June 2026.
- 2.2. The GNSK organization charges a registration fee, which must be paid in advance. Only then will an accreditation card be issued.
- 2.3. Participation rights are strictly personal. The GNSK organization reserves the right to annul results and impose fines in the event of violations.
- 2.4. Participants are required to report changes in personal details as soon as possible by email to the GNSK organization via info@studentensport.nl. If changes are communicated after 30 April 2026 and result in incorrect details on accreditation cards, access to the GNSK may be denied.

3. Registration and Payment

- 3.1. The registration deadline is 30 April 2026.
 - 3.2. The registration fee is €36.50 per person for athletes and €21.00 per person for team officials (such as coaches, trainers, supervisors, managers, physiotherapists, etc.).
 - 3.3. Registration is only final once the full registration fee has been paid.
 - 3.4. Each participant and team official must be registered individually.
 - 3.5. Any optional extras relating to accommodation, meals, and the party must be indicated and paid for during the registration of each participant or team official. The fees for these extras are charged in addition to the registration fee as stated in article 3.2.
- Changes to extras are possible until the registration deadline of 30 April 2026 and must be submitted by email to info@studentensport.nl.
- 3.6. If participants compete as part of a team, the team captain must first register the team via a Google Form. After approval by the organization, team players can register individually via the Aanmelder platform and link themselves to the team they will represent. Registration links can be found on the GNSK website.
 - 3.7. Both during pre-registration and on-site registration at the GNSK, proof of enrolment will be requested to verify that the participant is indeed a student at the affiliated educational institution in the relevant city.

4. Cancellation

- 4.1. The cancellation deadline is 30 April 2026.
- 4.2. Cancellation of registration must be submitted by email to info@studentensport.nl.
- 4.3. Refunds of the registration fee already paid (including extras) will be processed after the event.
- 4.4. In case of cancellation before the cancellation deadline of 30 April 2026, the refund will consist of the paid registration fee (including extras) minus an administrative and processing fee (€25.00 per person per cancelled registration).

4.5. In case of withdrawal after the cancellation deadline of 30 April 2026, no refund will be granted and a fine may be imposed. Withdrawal must be submitted by email to info@studentensport.nl, stating the reason for cancellation.

5. Sports Programme

- 5.1. The GNSK organization will present the sports programme digitally.
- 5.2. The organization strives to ensure that the full sports programme offered takes place.
- 5.3. The GNSK organization reserves the right to make changes to the sports programme at any time if deemed necessary.
- 5.4. The GNSK organization is obliged to inform all participants of any changes via available communication channels.
- 5.5. If a part of the sports programme cannot take place, this will be communicated by email and the full registration fee (and extras) will be refunded to participants and team officials of the relevant sport.

6. Liability

- 6.1. Participation in the GNSK is at one's own risk. Participants and team officials must at all times comply with the sport-specific rules as laid down in the competition regulations.
- 6.2. The GNSK organization is not liable for damage to, loss of, or theft of personal belongings.
- 6.3. Damage caused by vandalism or improper use will be recovered from the responsible party or parties.

7. Obligations of the GNSK Organization

- 7.1. The GNSK organization is responsible for the required maintenance of facilities during the event.
- 7.2. The GNSK organization is responsible for ensuring that event locations are staffed with a sufficient number of people with the appropriate skills, qualifications, and certifications.
- 7.3. The GNSK organization will provide sufficient first aid facilities at the various sports locations.
- 7.4. The GNSK organization is responsible for providing the correct documentation to all participants and team officials as proof that they meet the participation requirements.
- 7.5. The GNSK organization is responsible for the organisation of the entire event weekend from 5 to 7 June 2026, including the sports programme, an additional programme and party, accommodation, and catering.

8. Obligations of Participants and Team Officials

- 8.1. Participants and team officials are required at all times to follow the instructions of the GNSK organization and to comply with all regulations of the organization and the sports venues.
- 8.2. Improper use of equipment or facilities without prior consultation with the GNSK organization is strictly prohibited.
- 8.3. Participants and team officials may not use sports facilities while under the influence of alcohol and/or drugs, or when substances classified as doping are involved.
- 8.4. Smoking is not permitted on the campus grounds or at other sports locations.

9. Privacy Policy

- 9.1. The processing of personal data is subject to the privacy statement.

10. Complaints Procedure

- 10.1. Suggestions or complaints may be sent by email to info@studentensport.nl and must include at least the sender's name and contact details. The GNSK organization aims to respond to suggestions or complaints by email within 7 days.

11. Force Majeure

11.1. The GNSK organization is not liable for failure or partial failure to fulfil its obligations if this is the result of force majeure.

11.2. Force majeure is understood to mean any circumstance beyond the control of the organization that wholly or partially prevents the fulfilment of obligations, including but not limited to extreme weather conditions, pandemics, government measures, strikes, technical failures, failure of facilities, or other unforeseen circumstances.

11.3. In the event of force majeure, the GNSK organization reserves the right to modify, suspend, or cancel the event, the sports programme, or parts thereof.

12. Applicable Law

12.1. These general terms and conditions are governed by Dutch law.
